PROVEN

A Fortune-10 multinational conglomerate wanted to streamline their P2P process for higher efficiency. Their existing manual effort intensive process was causing high invoice holds, delayed payments, 35% discount loss, frequent supplier queries & over 5 days of processing time.

DOMAI

Datamatics process consultants mapped the existing processes & performed gap analysis to identify scope for optimization. A P2P process automation solution combined with right-shored services was proposed. Datamatics solution comprised invoice receipt TM TM automation, imaging, capture using 'iQ' technology & ePM+ workflow automation tool to manage exceptions, approvals, statement reconciliation, vendor maintenance & ERP integration for automated posting. The solution was implemented in 8 weeks followed by 4 weeks of ramp up & steady state.

The solution reduced processing time from 5 days to 2 days, invoice holds from 60% to 40%, & discount lost cases from 35% to 5%. Supplier's queries also reduced substantially with faster processing & higher accuracy. Enhanced analytical capabilities enabled better business decisions.
