# **BUSINESS OVERVIEW**

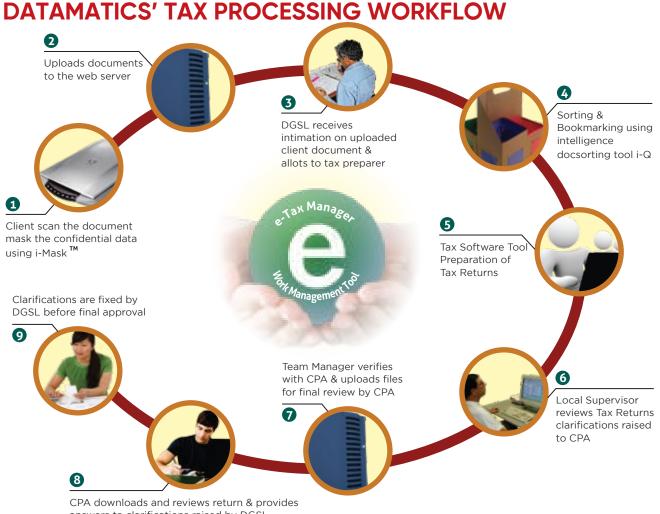
