## RE-CLASSIFICATION FROM 'PROMOTER GROUP' CATEGORY TO 'PUBLIC' CATEGORY:

Ms. Divya Kumat, EVP, Chief Legal Officer & Company Secretary informed the Board that the Company has received a request letter dated May 09, 2022 from Mrs. Aneesha Dalmia and Mrs. Amrita Bhogilal ("hereafter referred to as Outgoing Promoters"), daughters of Dr. Lalit S. Kanodia and Mrs. Asha L. Kanodia (Promoters of the Company) seeking re-classification of their shareholding from "person belonging to the promoter group" to "Public" category under Regulation 31A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations").

She further informed the Board that Mrs. Aneesha Dalmia and Mrs. Amrita Bhogilal presently hold 3,19,143 (0.43%) and 2,52,874 (0.54%) shares respectively in Datamatics Global Services Limited ("Company") as immediate relatives of the Promoters i.e. Dr. Lalit S. Kanodia and Mrs. Asha L. Kanodia, are currently classified as "person belonging to the promoter group" in the Shareholding Pattern of the Company, and are now seeking re-classification of their shareholding from "person belonging to the promoter group" to "Public" category.

The Board analysed the request received from the Outgoing Promoters and considering the rationale provided by the Outgoing Promoters in their request letter, subject to the confirmation that they satisfy the requirements of Regulation 31A of the Regulations, the Board accorded its consent to the requests made by the Outgoing Promoters for reclassification from "person belonging to the promoter group" category to "Public" category.

Thereafter, the Board is also required to intimate the stock exchanges and file the requisite application for re-classification, as requested.

Accordingly, Board considered the matter and passed the following resolutions unanimously:
