H1 FY17-18 revenue increased to Rs. 440.66 crore

November 30, 2017, Mumbai: Datamatics Global Services Ltd. Q2 FY17-18 Performance – Consolidated (Q-o-Q)

- **Revenue** increased to **Rs. 232.09 crore** as compared to Rs. 208.57 crore in Q1 FY17-18.
- **EBIDTA** stood at **Rs. 19.12 crore** as compared to Rs. 19.07 crore in Q1 FY17-18.
- **Net profit** of **Rs. 21.69 crore** as compared to Rs. 16.07 crore in Q1 FY17-18.

H1 FY17-18 Performance – Consolidated (Y-o-Y)

- **Revenue** increased to **Rs. 440.66 crore** as compared to Rs. 417.76 crore in H1 FY16-17. On a constant currency basis, the consolidated revenue grew by **9.18%**.
- **EBIDTA** stood at **Rs. 38.18 crore** as compared to Rs. 48.94 crore in H1 FY16-17.
- **Net profit** after minority interest of **Rs. 37.76 crore** as compared to Rs. 35.56 crore in H1 FY16-17.
