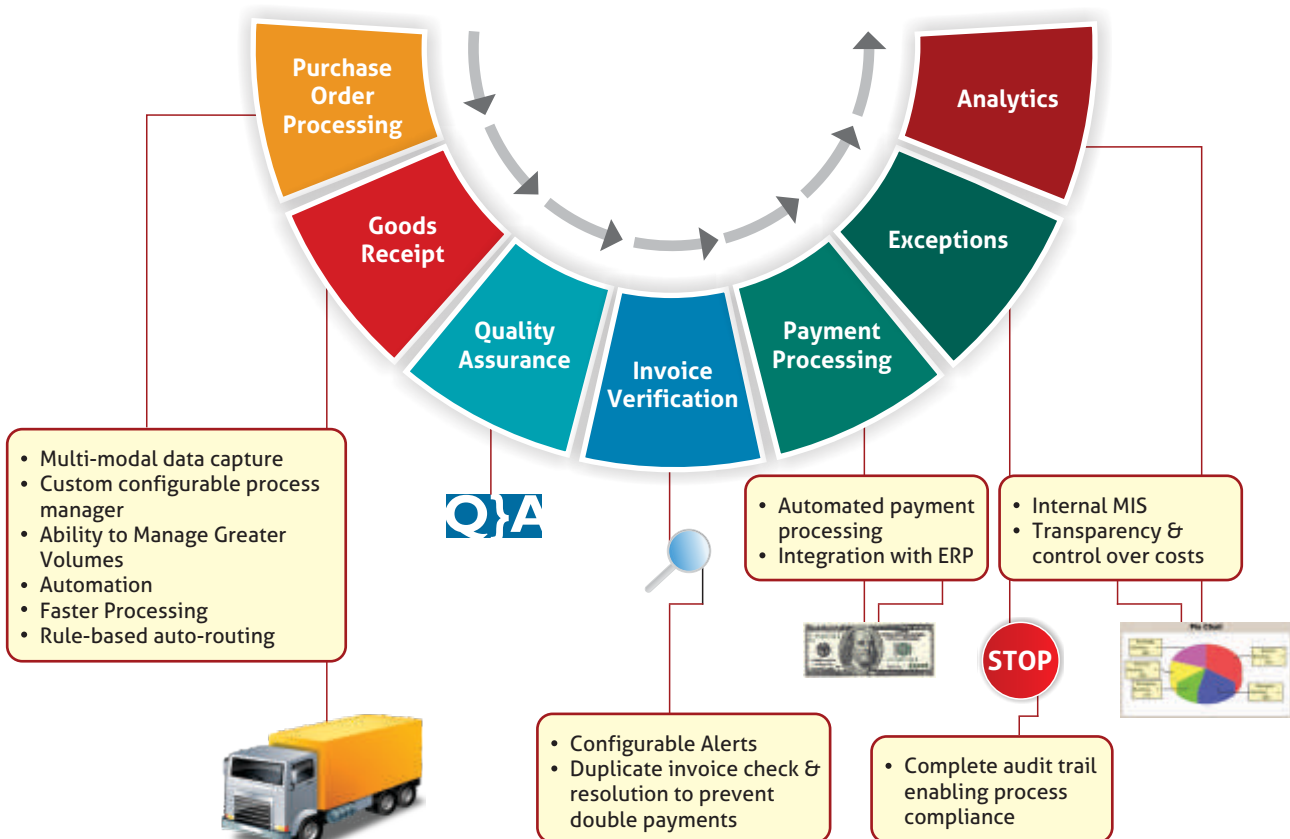

Success Story

A leading multinational publisher & information services company, with a turnover of over €3.5 billion was facing AR challenges related to a high value of cash receipts outstanding, duplicate payments due to wrong invoicing, high levels of unapplied cash & customer queries, with 86 days of turnaround time.

Datamatics conducted a detailed AR process mapping & gap analysis exercise & proposed an AR automation solution with a right-shoring approach. Datamatics solution comprised document receipt automation, image capture using "IQ" technology & AR automation using eRM workflow tool. The solution was designed to manage exceptions, approvals, statement reconciliation, customer maintenance & automated cash application using ERP integration. Entire solution was implemented in 8 weeks followed by 4 weeks of ramp up & steady state.

Datamatics solution reduced overall AR past dues by from 86 days to just 31 days & reduced unapplied cash by \$ 5 million within 9 months. The right-shoring approach enabled the provision of a variable resource base as & when required, through out the year, thus converting fixed team-cost into a variable operations cost for the client.
